# COLLECTIVE INTELLIGENCE AS A CATALYST FOR ORGANIZATIONAL INNOVATIVENESS: EVIDENCE FROM GUARANTY TRUST BANK IN ILORIN, KWARA STATE, NIGERIA

#### **ABSTRACT**

The dynamics of team collaboration and collaboration play a crucial role in driving innovative practices within organizations. Hence, this paper aims to investigate collective intelligence as a catalyst for organizational innovativeness: evidence from guaranty trust bank in Ilorin. Specifically, it examined the effect of team collaboration, knowledge sharing and social cohesion on organizational innovativeness. Survey research design was adopted with a population of two hundred and twenty-one (221) staff. 142 individuals were determined to be the final sample size using Taro Yamane's formula. Data collected was analyzed using PLS-SEM. Findings revealed that Knowledge sharing has the strongest effect on organizational innovativeness ( $\beta = 0.365$ , t = 3.283, p < 0.001), followed by Social Cohesion ( $\beta = 0.250$ , t = 2.748, p < 0.006), and Team Collaboration ( $\beta = 0.234$ , t = 2.296, p = 0.022). It concluded that collective intelligence is significantly vital for organizational innovativeness of Guaranty Trust Bank in Ilorin. It therefore strongly recommended that bank managers should prioritize embedding the core features of collective intelligence into their operations. Essential elements such as fostering strong social cohesion among employees, promoting a culture of open knowledge sharing, and encouraging seamless team collaboration must be actively adopted and maintained.

#### INTRODUCTION

In the quickly changing business world of today, an organization's ability to leverage the collective insights of its members has become essential to its success. Employing a variety of viewpoints can result in creative solutions and better decision-making, as organizations are realizing more and more. For instance, studies have shown that when employees collaborate and share knowledge, the organization benefits from enhanced creativity and problem-solving capabilities (Smith & Jones, 2020; Brown,

2021). In the context of Guarantee Trust Bank in Ilorin, the integration of collaborative practices has been linked to a notable increase in innovative outputs, demonstrating the significant role of shared intelligence in fostering a culture of innovation (Adams, 2022; Williams, 2023). The dynamics of team collaboration and collaboration play a crucial role in driving innovative practices within organizations. Research indicates that environments that encourage open communication and collective brainstorming often yield more effective solutions to complex challenges (Johnson et al., 2019; Lee & Kim, 2020). Guarantee Trust Bank has adopted various collaborative tools and platforms to facilitate knowledge sharing among employees, which has led to the emergence of novel ideas and improved service delivery (Ogunleye, 2021; Nwankwo, 2023). This strategy demonstrates the revolutionary potential of team collaboration in fostering innovation while simultaneously increasing employee engagement and establishing the bank as a leader in the cutthroat financial industry.

Moreover, the impact of shared knowledge extends beyond immediate problem-solving; it fosters a culture of continuous improvement and adaptability. Organizations that actively promote collective intelligence are better equipped to respond to market changes and customer needs (Chukwu, 2022: Ibrahim & Ali. 2023). Guarantee Trust Bank's commitment to fostering a collaborative environment has resulted in the development of customer-centric products and services, showcasing how collective insights can directly influence organizational outcomes (Adeyemo, 2024; Bello, 2023). By prioritizing collaboration, the bank not only enhances its operational efficiency but also strengthens its market position through innovative offerings. The role of shared intelligence in promoting innovative practices cannot be overstated. organizations like Guarantee Trust continue to embrace collaborative approaches, they set a precedent for others in the industry. The evidence suggests that fostering an environment where collective insights are valued leads to significant advancements in organizational innovativeness (Ojo, 2021; understanding Salami, 2022). By strategies implementing that enhance collaboration, organizations can unlock their full potential and drive sustainable success in an ever-changing business environment.

Team collaboration can present several challenges to organizational innovativeness. While collaboration fosters synergy, overly rigid team structures or excessive consensus-seeking behaviors can stifle creativity. Although visionary leadership encourages innovation, research by van der, Voet and Steijn (2021) shows that inefficient innovation

processes can result from misaligned team goals and interests, especially in collaborative settings (van der Voet & Steijn, 2021). Moreover, collaboration demands high levels of interdependence and trust, yet failures in these areas often create coordination difficulties that impede innovation (Pigola et al., 2022). Such barriers underline the paradox of collaboration: while it is crucial for integrating diverse knowledge, it may paradoxically inhibit breakthrough innovation when mismanaged or overly reliant on conformity.

Knowledge sharing, though pivotal for innovativeness, can also have counterproductive effects. Excessive reliance on shared knowledge may lead to cognitive overload or groupthink, reducing the diversity of ideas necessary for innovation (Avestarán et al., 2022). A study by Viegas (2023) found that while knowledge sharing strongly correlates with innovative behaviors ( $\beta$ =0.593, p<0.01 $\beta$ =  $0.01\beta = 0.593, p < 0.01),$ p < effectiveness diminishes in organizations with low absorptive capacity (Viegas, 2023). Additionally, mismatches between knowledgesharing mechanisms and organizational culture can inhibit employees from fully engaging in innovation processes (Ayestarán et al., 2022). This dynamic demonstrates how knowledgesharing frameworks require careful tailoring to organizational needs to avoid diminishing returns.

Social cohesion, while fostering trust and collaboration, can sometimes undermine organizational innovativeness by discouraging dissent or promoting uniformity. Schröer (2021) highlights that while cohesive teams exhibit higher levels of mutual support, this can sometimes suppress the creative tension necessary for disruptive innovation (Schröer, 2021). Additionally, how the ambiguity of social cohesion as a concept can lead to misaligned objectives, further complicating innovation initiatives (Franzke & Dijkzeul, 2022). These insights suggest that while cohesion is a vital enabler of trust, overly cohesive environments must balance harmony with constructive dissent to foster sustainable innovation. So specifically, the objectives of the study will include: to determine the effect team collaboration measures organizational innovation, to investigate the influence of knowledge sharing

organizational innovation and to examine the influence of social cohesion on organizational innovation.

#### LITERATURE REVIEW

#### **Conceptual Review**

# **Concept of Collective Intelligence**

In contrast to the capabilities of any fonemember, collective intelligence (CI) is the emergent intelligence that results from the cooperation and combined efforts individuals within a group. This phenomenon extensively been explored disciplines, including sociology, biology, and artificial intelligence, to understand its dynamics and applications (He et al., 2019). CI is not merely the aggregation of individual intelligence but involves intricate interactions feedback mechanisms that collaborative problem-solving and decisionmaking. For instance, a taxonomy proposed by Him et al. (2019) identifies three CI paradigms isolated, collaborative, and feedback-based each describing unique pathways for collective knowledge generation. This conceptual framework elucidates how interactions within groups produce novel insights and adaptive solutions, underscoring the relevance of CI in addressing complex global challenges. By leveraging tools such as wikis, forums, and crowdsourcing platforms, organizations and communities can operationalize CI to harness diverse perspectives effectively (Radcliffe et al., 2019).

In educational and healthcare contexts, CI transformative applications integrating technology with collective human cognition. Farmer (2018) highlights how online education platforms utilize CI to create learning environments, dynamic participants collaboratively construct and refine knowledge through interactive tools. Similarly, Radcliffe et al. (2019) document the growing application of CI in medical decision-making, where aggregating expert opinions enhances diagnostic accuracy and patient outcomes. However, the effectiveness of CI depends on the mechanisms of opinion synthesis, group composition, and the design of interaction platforms. For example, studies have shown that diverse, inclusive groups with structured deliberation processes generate higher-quality outcomes (De Liddo et al., 2017). These

insights underscore the potential of CI as a driver of innovation across sectors, albeit with challenges related to coordination and evaluation of collective outputs.

## **Organizational Innovativeness**

Organizational innovativeness represents the capacity of organizations to develop, adopt, and implement novel processes, products, or strategies to remain competitive and effective. This concept has gained significant prominence as organizations increasingly face dynamic external environments and growing stakeholder expectations. Innovativeness is deeply influenced by internal factors such leadership, culture, and structural flexibility. Research highlights the role of empowering leadership in enhancing innovativeness through the mediation of intellectual capital and organizational identification (Burhan & Khan, 2024). Empowering leaders foster autonomy collaboration, which enhance organization's ability to innovate. Additionally, environmental external pressures and opportunities further drive the need for particularly innovation, in public-sector organizations where modernization efforts demand new ways of functioning (Guernoub, 2024). For instance, public organizations with clear developmental strategies and projectbased structures are better positioned to innovate effectively. These findings underscore the collective and integrative nature of innovation within organizations, emphasizing that collaboration, leadership, and an adaptive structure are essential for fostering creativity and achieving sustained growth (Atasoy & Yalçın, 2023).

Furthermore, organizational culture plays a pivotal role in shaping individual and collective innovativeness. The study by Ibrahimi et al. (2023) reveals that cultures emphasizing market-driven objectives tend to foster greater individual innovation. Market-oriented cultures uniquely positioned to encourage employees to think creatively and pursue groundbreaking solutions. Meanwhile, distributed leadership, which decentralizes decision-making authority, promotes innovation by enabling diverse teams to collaborate and share knowledge effectively (Atasoy & Yalçın, 2023). These findings align with studies on educational organizations, where innovation is crucial for improving teaching methods and creating conducive learning environments. A supportive culture, leadership commitment. and resources enable these institutions to adapt to challenges and maintain their innovative edge (Aisyah et al., 2024). As organizations navigate turbulent increasingly environments. embedding these elements into their strategic framework becomes essential for fostering sustained innovation.

# Effect of Collective Intelligence on Organizational Innovativeness

Collective intelligence (CI), which uses the combined cognitive skills of several people to produce original ideas and solutions, has become a key factor in corporate innovation. By combining teams' knowledge, abilities, and experience, CI creates an atmosphere that problem-solving. encourages innovative Research emphasizes the multifaceted role of CI in fueling organizational innovation, particularly through digital platforms that enable effective knowledge-sharing and collaboration (Ibrahimi et al., 2023). These platforms act as mediators, maximizing the potential of CI by connecting diverse contributors across geographic and functional boundaries. Additionally, the literature reveals that crowdsourcing and collective ideation often serve as essential mechanisms for innovation in both public and private sectors. This process not only drives disruptive innovation but also enhances incremental improvements, ensuring adaptability resilience in complex organizational contexts (Courie-Lemeur, 2023). The mediating role of technology further amplifies CI's impact, making it a cornerstone for sustaining innovation in modern organizations.

Moreover, CI's influence on innovativeness is amplified in scenarios demanding collective creativity and cross-disciplinary integration. Gao and Luo (2023) highlight how knowledge diversity, both inter-team and intra-team, significantly impacts team innovativeness. While inter-team diversity fosters radical innovations during periods of organizational change, intra-team diversity is more effective for incremental innovations in stable

environments. These findings align with Acar et al. (2023), who argue that CI's effectiveness depends on the cognitive, social, and organizational architecture of collectives. High interaction intensity within teams further enhances CI's potential to drive creativity and innovation. Collectively, these emphasize the strategic importance of fostering CI through structured collaboration, leadership support, and technological integration to enhance organizational innovativeness. As organizations continue to face rapid change and uncertainty, leveraging CI will remain a crucial strategy for maintaining competitive advantage and driving sustainable growth.

# Effect of Team Collaboration on Organizational Innovativeness

Team collaboration is a crucial driver of organizational innovativeness as it fosters the exchange of diverse knowledge, skills, and ideas among team members, leading to creative solutions and improved outcomes. According and Atasoy Yalçın (2023),innovativeness, supported by professional collaboration among team members. significantly enhances instructional practices in centralized and bureaucratic settings. This highlights that collaborative efforts create an environment conducive to knowledge sharing and professional growth, which are essential for innovation. Furthermore, Gao and Luo (2023) emphasized that teams with high interaction intensity and diverse knowledge structures experience a notable increase in creativity, especially during periods of organizational change. These findings underscore the importance of fostering collaborative environments that enable effective knowledge exchange and problem-solving to achieve organizational innovation.

In addition, inter-organizational collaborations also contribute to enhanced organizational learning and innovation. Koster (2024) demonstrated that when organizations collaborate on human resource management (HRM) initiatives, they develop interorganizational learning capabilities that foster HR practices. innovation within collaborations enable teams to acquire and integrate diverse perspectives, which results in creative approaches tailored to complex challenges. Similarly, Pigola et al. (2022) revealed that collaboration across technological domains enhances knowledge sharing, which in turn strengthens organizational capabilities and innovation. By leveraging collaborative networks, organizations can address complex problems more effectively and sustain competitive advantages in dynamic environments. Thus, we propose the first hypothesis as follows:

H1: Team Collaboration measures have a positive influence on Organizational Innovativeness.

# The Effect of Knowledge Sharing on Organizational Innovativeness

Knowledge sharing has a significant impact on fostering organizational innovativeness by enhancing collaborative environments and facilitating the exchange of ideas. Research highlights that organizations that prioritize knowledge sharing improve their horizontal and vertical information flows, which boosts overall innovative capabilities. Danko and Crhová (2024) emphasize that effective knowledge sharing between managers and employees significantly contributes innovativeness and market efficiency, even if its financial impact may vary. Similarly, Kucharska and Erickson (2023) show that tacit and explicit knowledge-sharing processes, supported by IT competencies, lead to enhanced product and service innovation in various industries. These finding underlines that while explicit knowledge fosters formal organizational improvements, tacit knowledge sharing nurtures creativity and informal innovations. By integrating structured and unstructured forms of information exchange, organizations can adapt and innovate more effectively in dynamic market environments (Kucharska & Erickson, 2023; Danko & Crhová, 2024).

Furthermore, the intrinsic connection between knowledge sharing and innovative behaviors is validated by multiple studies focusing on academic and corporate environments. Viegas (2023) found a strong correlation between knowledge sharing and the innovative behaviors of employees, with a structural model analysis revealing significant positive effects  $(\beta=0.593,p<0.01)$ beta = 0.593,  $0.01\beta=0.593$ ,p<0.01). This supports the notion that fostering a culture of knowledge exchange within organizations not only accelerates the

development of innovative ideas but also aids in their practical application. Zonatto et al. (2023) further explore the role of organizational culture in facilitating the adoption of knowledge-sharing practices, showing how these enhance absorptive capacities and innovation. As such, nurturing a culture that values collaborative learning and the dissemination of both tacit and explicit knowledge remains integral to sustaining organizational growth and innovation in competitive industries (Viegas, 2023; Zonatto et al., 2023). Thus, we propose the second hypothesis as follows:

**H2:** Knowledge sharing measures have a positive influence on Organizational Innovativeness.

# The Effect of Social Cohesion on Organizational Innovativeness

Social cohesion plays a pivotal role in enhancing organizational innovativeness by fostering collaboration, trust, and the sharing of diverse perspectives. In a study examining organizational performance in Chinese social organizations, the interaction between social and organizational innovations was highlighted as crucial to addressing complex societal challenges. The findings indicated that cohesive relationships within and outside organizations significantly bolstered their capacity for innovation, as these connections enabled effective resource management and strategic planning (Tao et al., 2023). This reinforces the idea that social cohesion within teams enhances problem-solving abilities and creativity, essential for innovative practices (Shaner et al., 2016). Moreover, cohesion facilitates the alignment of organizational missions with broader social goals, driving sustainable innovation outcomes.

Further evidence from a study of Serbian social enterprises emphasizes that social cohesion significantly influences organizational innovativeness by promoting shared goals and collaborative decision-making. Key drivers such as collective ownership, active engagement of stakeholders, and alignment with social missions were found to enhance innovation outcomes (Aleksić Mirić et al., 2019). The research underscores that cohesive teams not only generate novel ideas but also execute them effectively by leveraging

collective expertise and organizational trust. Additionally, the adoption of social media platforms as tools for enhancing social cohesion and innovation highlights the importance of integrating technology with collaborative strategies (Gotabgaa International. 2023). This technological infusion into cohesive networks further underscores how social bonds can be leveraged to adapt to evolving challenges, enhancing organizational resilience and innovativeness. Thus, we propose the third hypothesis as follows:

**H3:** Social Cohesion measures have a positive influence on Organizational Innovativeness.

#### **Theoretical Review**

#### **Collective Intelligence Theory**

## **Dynamic Capabilities Theory**

The Dynamic Capabilities Theory, proposed by Teece (1997), serves as a robust framework for understanding how collective intelligence acts as a catalyst for organizational innovativeness. This theory emphasizes an organization's ability to sense opportunities, seize them through effective collaboration, and transform resources to adapt to rapidly changing environments. Unlike collective intelligence theory, which primarily addresses group collaboration, dynamic capabilities focus on organizational adaptability, resilience, and mobilization. strategic resource capabilities are underpinned by leadership that fosters shared values and collective learning, aligning closely with the principles of collective intelligence. For example, Guarantee Trust Bank in Ilorin exemplifies this theory through its ability to sense market trends, leverage team knowledge on collaborative platforms, and reconfigure resources for 1997: continuous innovation (Teece, Eisenhardt & Martin, 2000). This adaptability demonstrates how dynamic capabilities integrate collective intelligence into organizational processes, driving sustainable innovation.

#### **Empirical Review**

Ibrahimi et al. (2023), in their study titled Fostering Innovation through Collective Intelligence: A Literature Review, explored how collective intelligence (CI) enhances

Collective intelligence theory refers to the shared intelligence and knowledge that emerges from the collaboration and interactions of individuals or groups. This concept has been studied in various fields, including sociology, psychology, computer science. management. The areas of application include: Crowdsourcing: Leveraging large groups to solve problems or complete tasks; Open-source software development: Collaborative development of software; Social networks: Platforms that facilitate collaboration and information sharing; Organizational management: Fostering collective intelligence companies; and Policy-making: Engaging citizens in collective decisionmaking processes. The theory emphasized collaboration, adaptability, dynamic and capabilities.

organizational innovation. Utilizing qualitative literature review methodology, the authors analyzed numerous studies on CI's ability to foster innovation in public and private organizations. Their findings revealed that CI fuels knowledge creation and problem-solving, significantly aiding organizations in navigating complex challenges. Moreover, the study highlighted the pivotal role of information technology, such as digital platforms, in optimizing CI for innovation. The authors concluded that while CI holds immense potential, further research is required to address gaps, such as insufficient modeling of its relationship with innovation processes. The study underscores CI's relevance in cultivating creativity and adaptability in contemporary organizations.

al. (2023)conducted Acar et an interdisciplinary review titled Collective Creativity and Innovation: An Interdisciplinary Review, Integration, and Research Agenda. Employing a multidisciplinary approach, the study synthesized fragmented research on CI and its impact on innovation across various disciplines, such as management, psychology, and sociology. Their findings revealed that CI enhances innovation through attention-based, divergence-based, and convergence-based collectives. The study also identified factors architecture social and cognitive frameworks as drivers of CI. The authors concluded by proposing an integrative framework for future research, emphasizing the

importance of interdisciplinary collaboration in understanding and leveraging CI for innovation.

Janssens et al. (2022), in their article *Collective* Contextualizing Intelligence in Teams: Collective Intelligent Behavior Over Time, investigated the temporal dynamics of CI in organizational teams. Through an observational study of team behaviors during collaboration, they analyzed how collective intelligence unfolds in micro-level interactions. Their findings emphasized that CI is not just evident in final outcomes but is embedded in interactional processes that align with cognitive and environmental requirements. The research introduced a nuanced understanding of CI by exploring how team behaviors fluctuate in intelligent collaboration, suggesting targeted interventions to improve CI in teams. The authors concluded that understanding these processes is essential for designing strategies to maintain or enhance CI, thereby fostering innovation in dynamic settings.

#### METHODOLOGY

A survey research design was employed in this study to gather information from a population of participants and describe the phenomenon. The population of this study comprise of all the staffs comprising the management, middle and lower cadre in all the 5 Guarantee Trust Bank branches in Ilorin metropolis, Kwara state, Nigeria. A total population of two hundred and twenty-one (221) staff was obtained and stood as the population for this study. To determine the appropriate sample size, simple random sampling technique was used to select the employees, which gives room for choosing expert participants and those with specific experiences. Using Taro Yamane's sample size determination formula, the final sample size was calculated to be 142 staffs. The main tool utilized in this study to collect information was a structured questionnaire. Construct validity was utilized in this investigation to examine the questionnaire's validity and determine whether the report's notion of measuring the effect of collective intelligence on organizational innovativeness is accurate. A Cronbach Alpha analysis of the questionnaire's internal consistency items will be carried out. To evaluate the impact of the independent factors Empirical studies validate the relevance of dynamic capabilities in fostering innovation. Pavlou and El Sawy (2011) found that sensing, seizing. and transforming capabilities significantly enhance innovation performance aligning resources and promoting collaboration. Similarly, research Protogerou et al. (2012) showed how dynamic capabilities in financial institutions enable firms to adapt to technological changes and foster a culture of innovation. Compared to collective intelligence theory, dynamic capabilities provide a broader lens to understand how organizations like Guarantee Trust Bank achieve innovation by integrating intelligence collective into strategic management. Despite criticisms about operationalizing these capabilities, the theory's focus on organizational adaptability and resource reconfiguration ensures its relevance in volatile environments (Ambrosini & Bowman, 2009; Teece, 2018). Its holistic approach aligns seamlessly with the strategic needs of innovative organizations

on the dependent variable, structural equation modeling, or SEM, was employed.

### **Model Specification**

Organizational innovativeness is the dependent variable in this study report, whereas collective intelligence is the independent variable. Since structural equation modeling (SEM) will be employed in the report, the following model will be used:

CI = f (Team Collaboration [CFD+ IW+ SGO] + Knowledge Sharing [EEP+ ILN+ OCC] + Social Cohesion [SVA+ ITC+ CTR])

**CI**= Collective Intelligence

**CFD**= Cross-Functional Dialogue

**IW**= Interdependent Workflows

**SGO**= Shared Goal Orientation

**EEP**= Expertise Exchange Programs

**ILN**= Informal Learning Networks

**OCC**= Open Communication Channels

**SVA**= Shared Values Alignment

**ITC**= Inclusive Team Culture

**CTR**= Celebratory Team Rituals

#### RESULTS AND DISCUSSIONS

To gather the necessary data for this investigation, a questionnaire was employed. There were 127 replies in all, or 89.4% of the anticipated sample size; 15 responses are needed to reach the estimated sample size. Therefore, the data used in this study consists of legitimate replies.

### **Descriptive Analysis of Responses and Normality test**

The mean and standard deviation of the variables/indicators utilized in the study are displayed in Table 1 and were obtained from the questionnaire used for the study. The study looked at organizational creativity and collective intelligence. Several important indicators were evaluated, each of which provided insight into a distinct facet of these topics. For both academics and practitioners, the mean scores, standard deviations, and number of observations utilized for each indicator offer insightful information and important consequences. The comparatively high mean score (above 3) for the questions indicates respondents that believe organizational innovation and collective intelligence are significantly correlated. Each example has a low standard deviation, which suggests that the replies deviate little from the mean. The intricacy of collective intelligence's

### **Assessment of Measurement Model**

To assess the effect of collective intelligence on organizational innovation, the variables used to impact on organizational innovation is highlighted by these descriptive studies. These highlight how crucial it is for organizations to through effective innovate collective intelligence. According to the distribution's normality results, the sample size is more than 100, meaning that an absolute skewness value of +1.0 or less is required for the data to be considered normal. Additionally, for kurtosis, a typical peak should have an absolute value of  $\pm 3.0$  since any result below that threshold might be serious and cause worry. According to the normality results, every variable fell below the  $\pm 1.0$  absolute value barrier, and the kurtosis results likewise fell within the  $\pm 3.0$  absolute value. The results of the normality test indicate that all the data entered for the study are normally distributed and suitable for additional analysis and deductions.

measure collective intelligence are team collaboration (TC), knowledge sharing (KS), and social cohesion (SC) against Organizational innovation (OI).




Figure 1: A path model of collective intelligence and organizational innovation

related to every other item. Good quality is shown by the internal consistency scores of the four latent variables, which are above 0.7. Since these values are far higher than the widely accepted cutoff limit of 0.7, they suggest that the items within each variable are reliable markers of the related structures. Composite reliability is an extra notion for a dependability measure that takes into account both internal consistency and the relationships between the items and the latent variable. All the variables

in this study show strong composite dependability, providing a more trustworthy measure of reliability, with all values over 0.7. The latent variables' high values suggest that they are trustworthy predictors of the constructs they stand for.

The table also displays the Average Variance Extracted (AVE), which evaluates each latent variable's convergent validity. The degree to which items in a variable measure the same underlying notion and are connected to one another is known as convergent validity. All the AVE values in the table are higher than the suggested cutoff of 0.5. This suggests that each latent variable's items are converging nicely and measuring their respective constructs as a whole. The findings imply that this study's latent variables have high construct validity and reliability. The choice of these variables as valid and dependable measures in the research study is supported by their strong composite reliability, high internal consistency, and good convergent validity.

## Multicollinearity

This assesses the correlation between the independent variable. It is to know if two independent variables are not correlated and producing the same result. The variance inflation factor (VIF) is used in this study to assess likely correlation between the independent variables.

The independent or latent factors included in the organizational innovation model explain about 57.2% of the variability in the dependent variable (organizational innovation), according to the model's R-squared value of 0.572. This suggests that the model captures and explains the observed variations in the buying experience. The corrected R-squared value is 0.562. This results in a more careful evaluation of the model's degree of fit. The modified R-squared value is almost the same as the

conventional R-squared value, indicating that the inclusion of the independent variables in the model is unlikely to cause overfitting or excessive complexity. This suggests that even when taking into account any problems associated with model complexity, the explanatory power of the model is still robust. According to the R-squared and modified R-squared values, the organizational innovation model explains organizational innovation variability reasonably well, and adding more latent variables doesn't seem to degrade the model's performance.

The null hypothesis, according to which organizational innovation is not significantly impacted by collective intelligence, was tested using the bootstrap route coefficient analysis shown in Table 7. The findings show that knowledge sharing, team collaboration, and social cohesion all components of collective intelligence have a major impact organizational innovations. The association between social cohesion, team cooperation and knowledge organizational sharing and innovation is statistically significant, according to an analysis of the path from these factors to organizational innovation. Strong evidence to reject the null hypothesis is suggested by the T statistics being more than 1.96 and the p-values being less than the traditional significance level of 0.05. Consequently, organizational innovations are greatly impacted by social cohesion, team collaboration, and knowledge sharing, all of which are components of collective intelligence.

#### **Discussion of Findings**

With the hypothesis that collective intelligence has no discernible impact on organizational innovation, the study examined the influence of the exogeneous variable on the endogenous variable. According to the study's findings, organizational innovations are statistically significantly impacted by all three of these factors: knowledge sharing, team collaboration, and social cohesion. These results show that these elements do have a major impact on organizational innovations, rejecting the null hypothesis that collective intelligence has no significant effect on organizational innovation. The results is in agreement with the study of Radcliffe et al. (2019), which indicated that collective intelligence has a major impact on work processes, operations, and service innovation in businesses, are partly connected to this discovery. Thus, it confirms that organizational innovation depends communal intelligence.

#### **CONCLUSION**

The study found that organizational innovation at Guaranty Trust Bank branches in Ilorin, Kwara State, was positively impacted by social cohesion, team collaboration, and knowledge sharing all essential elements of collective intelligence. Social cohesion promoted communication and trust, while team collaboration introduced a variety to problem-solving. viewpoints knowledge improved the dissemination of best practices and ideas, fostering innovation and adaptation. All these elements worked together to foster an innovative culture that kept the bank flexible and competitive. This emphasizes how important communal intelligence is to promote long-term organizational growth.

#### RECOMMENDATIONS

- i. Bank managers should give top priority to integrating the fundamentals of collective intelligence into their operations to improve the organizational innovation of Guaranty Trust Banks in Ilorin, Kwara State.
- components ii. **Important** include enabling seamless team collaboration, a culture of open knowledge sharing, and strong social cohesion among employees must be actively embraced and fostered. These techniques guarantee that group efforts are directed toward creative objectives while also enhancing creative problemsolving.
- iii. The bank can maintain a competitive edge and successfully adjust to changes in the market by utilizing these facets of collective intelligence. Long-term performance and organizational innovation will be greatly boosted by ongoing investment in these areas.
