

AI-DRIVEN COLD CHAIN MONITORING SYSTEMS AND THE PRESERVATION AND DISTRIBUTION OF VACCINES

ABSTRACT

The preservation and distribution of vaccines remain a critical challenge in Nigeria's Primary Health Care (PHC) system, where infrastructural limitations such as unreliable electricity, weak monitoring systems, and poor logistics undermine immunization programs. This study examines Artificial Intelligence (AI)-driven cold chain monitoring systems and preservation and distribution of vaccines in PHCs within the Federal Capital Territory (FCT), Abuja. Anchored on the Resource-Based View (RBV) theory, the study operationalizes AI through three proxies: machine learning, real time data analysis, and IOT sensor and evaluates their effects on vaccine spoilage, distribution efficiency, and availability. A case study research design was adopted with a sample of 300 immunization staff selected through stratified random sampling. Data were collected using structured questionnaires, semi-structured interviews, and observation checklists, and analyzed using descriptive and inferential statistics. Findings revealed that vaccine spoilage declined by 69% following AI adoption, while delivery lead time improved from 3.9 to 2.5 days and stock-outs dropped from 14% to 5%. Multiple regression analysis confirmed that AI proxies explained 68% of the variation in cold chain performance, with real time data analysis having the strongest effect ($\beta = 0.452$). The study concludes that AI significantly strengthens vaccine cold chain systems by reducing wastage, improving efficiency, and enhancing availability in PHCs. However, challenges such as unstable electricity supply, limited digital literacy among PHC staff, and inadequate funding constrain sustainability. It recommends scaling up AI deployment nationwide, investing in capacity building, and fostering collaborations between government and technology partners to achieve equitable and resilient vaccine distribution across Nigeria.

INTRODUCTION

The global supply of vaccines and biopharmaceuticals is currently a sensitive process (es) of supply chain management, particularly in ensuring public health security. Cold chain systems that ensure temperature-sensitive medicinal products to be kept and delivered within specified ranges are necessary for maintaining the potency of vaccines and

biopharmaceuticals (World Health Organization [WHO], 2022). Despite technological advances, the WHO estimates that nearly 25% of vaccines worldwide are compromised due to failures in cold chain management. This challenge has become even more urgent in the wake of the COVID-19 pandemic, which highlighted the need for resilient, technology-driven supply chains to enable mass immunization programs across diverse geographies (Patel et al., 2023).

Advanced economies had invested heavily in digital cold chain systems, inefficiencies such as delayed anomaly detection, reactive monitoring, and high spoilage rates persist (Zhang & Li, 2022) but traditional systems often detect spoilage only after vaccines have been compromised, posing significant risks to health outcomes. However, Artificial Intelligence (AI)-driven cold chain monitoring system now offers transformative opportunities by enabling real-time monitoring, predictive analytics, and optimized distribution. AI can ensure compliance with global storage standards, enhance inventory visibility, and predict risks before failures occur, thereby minimizing wastage and improving vaccine accessibility (Okafor & Ibrahim, 2024).

In Nigeria, these challenges are even more pronounced, especially in rural and underserved regions. Primary Health Care Centers (PHCs), which serve as the backbone of healthcare delivery and immunization at the grassroots level, face chronic infrastructural challenges such as unreliable electricity, inadequate storage facilities, and poor monitoring systems (National Primary Health Care Development Agency [NPHCDA], 2023). This has often resulted in vaccine wastage during national immunization campaigns for diseases like measles, polio, and COVID-19 (Gavi, 2022). Studies show that poor cold chain management is a leading cause of vaccine stockouts and wastage in PHCs, undermining Nigeria's progress toward achieving Universal Health Coverage (UHC) (Adebisi et al., 2022).

Given Nigeria's dependency on vaccines supplied through international partners such as WHO, UNICEF, and Gavi, there is an urgent need to modernize vaccine storage and distribution systems through AI-driven cold chain monitoring. These systems can support anomaly detection, vaccine stability prediction, and distribution optimization across national immunization programs, PHCs, and emergency response initiatives. For instance, AI-powered sensors and IoT-enabled monitoring devices can provide real-time alerts for temperature deviations in PHCs, even in remote areas with poor internet access, ensuring timely corrective

action (Nwankwo & Adeoye, 2021). This would significantly reduce vaccine spoilage, improve last-mile delivery, and enhance public trust in immunization programs.

Thus, integrating AI into Nigeria's PHC cold chain systems is not only critical for preserving vaccine potency but also for ensuring equitable healthcare delivery in underserved areas. By leveraging the roles of agencies such as NPHCDA, Federal Ministry of Health (FMoH), National Agency for Food and Drug Administration and Control (NAFDAC), and the Nigeria Centre for Disease Control (NCDC), AI-driven systems can strengthen PHC service delivery and reduce dependence on costly reactive interventions (Eze & Musa, 2025).

Despite the global emphasis on strengthening cold chain systems, Nigeria continues to experience persistent inefficiencies in vaccine supply and distribution. PHCs in rural areas lack reliable refrigeration, real-time monitoring, and adequate predictive systems, leading to high rates of vaccine wastage (UNICEF, 2023). National immunization campaigns often report stockouts, temperature excursions, and delayed deliveries, weakening public confidence in healthcare services (WHO, 2022).

The absence of AI-driven monitoring systems means anomalies are detected late, and corrective actions are reactive rather than preventive. Infrastructural challenges, including unreliable electricity and weak internet connectivity, further compound the problem, making it difficult to preserve vaccine efficacy at the community level (NPHCDA, 2023). As a result, preventable diseases continue to strain Nigeria's healthcare system, undermining progress toward Sustainable Development Goal 3: ensuring healthy lives and promoting well-being for all (Adebayo & Oladipo, 2024). The preservation and distribution of vaccines constitute a persistent challenge within Nigeria's Primary Health Care (PHC) system. Structural deficiencies including unreliable electricity supply, inadequate monitoring mechanisms, and inefficient logistics networks have consistently undermined the effectiveness of national

immunization programs. Building upon theoretical and applied insights derived from the Advanced AI in Supply Chain Management course under the instruction of Maya Balakrishnan (Assistant Professor, Operations Management, and University of Texas at Dallas), this study critically examines the role of AI-driven cold chain monitoring systems in addressing these deficiencies. Specifically, the research investigates how the integration of artificial intelligence into cold chain management can enhance vaccine preservation and improve distribution outcomes across PHCs in the Federal Capital Territory (FCT), Abuja

The main objective of this study was to examine the impact of AI-driven cold chain monitoring systems on the preservation and distribution of vaccines looking at Nigeria's Primary Health Care Centers. The specific objectives were to:

1. Assess the role of AI driven machine learning in reducing vaccine spoilage in PHCs.
2. Examine the effect of AI-based real time data analysis on vaccine stability prediction in PHCs.
3. Evaluate how AI-driven IOT sensors enhances vaccine accessibility in PHCs

Conceptual Framework

The conceptual framework envisions a layered architecture: IoT sensors feed real-time data into a live analytics platform, machine learning models embedded in the system generate anomaly-, stability- and optimisation-based intelligence, and the integrated AI-driven monitoring system delivers actionable outputs to PHC operators, logisticians and immunisation programmes. Through this, vaccine supply chains become more responsive, efficient and reliable — reducing wastage, improving access and strengthening immunisation outcomes in Nigeria's PHCs.

AI-Driven Cold Chain Monitoring Systems

an operational AI-Driven Cold Chain Monitoring System consist of systems/ML, real-

time data analysis, IoT sensors that embeds intelligence into vaccine storage, transport and distribution workflows in PHCs. In this architecture, the three operational proxies are manifested: anomaly detection, where deviations in temperature, power or transport conditions are detected in real time and prompt corrective action; vaccine stability prediction, where cumulative exposure and environmental data feed predictive models to estimate remaining viable life of vials (thus enabling decisions such as redistribution or utilisation before spoilage); and distribution optimization, where demand forecasts, vial-viability data and logistics constraints feed AI algorithms (e.g., route-optimisation, cold-box allocation, staffing scheduling) to maximise access and minimise wastage. The literature shows that such AI-IoT integrated systems reduce operational costs, enhance efficiency and improve cold-chain reliability, particularly for temperature-sensitive pharmaceuticals (Amos, 2024; Nozari et al., 2025). For Nigeria's immunisation programmes, these systems thus support improved access (faster delivery to PHCs), reduced wastage of vaccines and enhanced resilience of the cold-chain despite infrastructure and connectivity challenges.

Machine Learning

At the core of AI-Driven Cold Chain Monitoring is a systems architecture that embeds machine learning models into cold-chain operations so that the supply chain becomes proactively responsive rather than purely reactive. Machine learning algorithms ingest historical and streaming data — for example, cumulative temperature exposures, fridge door-open events, transport durations, ambient humidity, and immunisation demand patterns — and learn to detect anomalies, forecast vaccine stability and optimise distribution routes. For instance, advanced ML approaches enable anomaly detection by identifying subtle deviation patterns in temperature trajectories that traditional threshold-based alerts would miss (Harrabi, 2024). Similarly, ML-based predictive modelling has been shown to forecast cold-chain waste drivers by using IoT sensor data and environmental records (Leeds Business School

et al., 2025). In the context of vaccine supply chains in PHCs, these ML-enabled systems provide the intelligence to operationalise the proxies of anomaly detection, vaccine-stability prediction and distribution optimisation, thereby enhancing resilience and lowering wastage in Nigeria's immunisation programmes.

Real-time Data Analysis

Real-time data analysis forms the active monitoring layer of the framework, enabling insights to be generated, alerts to be issued, and corrective actions to be triggered in near-instant time. Continuous ingestion of sensor streams (temperature, humidity, power events, location) allows sliding-window analytics and short-interval summaries to feed the machine learning modules and optimisation engines. A typical implementation might aggregate data every few minutes, compute time-above-threshold metrics, flag excursions, and compute viability scores for vials in transit or storage. For example, a study of a vaccine cold-chain surveillance system demonstrates how 4G-gateway-enabled sensor modules coupled with cloud analytics deliver real-time visibility in both storage and transport phases (Jiang, Zhang, & Song, 2023). Real-time analytics thereby support immediate anomaly detection and feed the stability prediction and distribution-optimisation proxies of the framework. This ensures that the cold-chain system within PHCs remains agile, transparent and capable of responding to disruptions in Nigeria's challenging logistics context.

IoT Sensor

The IoT sensor component is the foundational data-capture layer of the framework and includes a network of devices embedded within storage units (e.g., refrigerators at PHCs), transport vehicles (cold-boxes, trucks, drones), and peripheral monitoring (door sensors, power meters, GPS trackers). These sensors continuously monitor key environmental and operational parameters such as temperature, humidity, door-open times, vehicle location, and

shock/impact events. Studies of vaccine cold chain systems underscore the critical role of IoT: for instance, one system describes a modular wireless sensor network feeding a cloud platform that enables remote query and alerting of temperature/humidity excursions (Jiang, Jia, & Guo, 2024). Further, IoT enables the seamless flow of data to the analytics and ML layers, and in low-connectivity or remote PHC settings (such as in parts of Nigeria) store-and-forward, edge-gateway resilience and mobile alerts are essential. Thus, IoT sensors provide the raw, real-time feed that underpins the anomaly detection, vaccine-stability prediction and distribution-optimisation mechanisms of the system.

Preservation and Distribution of Vaccines

The preservation and distribution of vaccines remain critical to sustaining global and national immunization targets. Vaccines are sensitive biological products that require strict adherence to temperature ranges to retain their potency. AI applications in the cold chain can reduce spoilage and improve equitable distribution across PHCs by predicting risks and reallocating resources dynamically. Thus, preservation and distribution are strengthened by AI-supported monitoring, which bridges systemic gaps in traditional cold chain management (Oladipo & Bello, 2024).

AI Anomaly Detection involves the deployment of real-time sensing devices and automated alerts to identify potential risks such as temperature excursions, power failures, or unauthorized door openings. By enabling early detection, PHC staff can act swiftly to prevent potency loss and reduce wastage. This process minimizes vaccine spoilage and strengthens trust in vaccine efficacy (Akinmolayan & Ogunyemi, 2023). Spoilage refers to wastage caused by temperature instability, mishandling, or extended storage beyond viability. By integrating AI anomaly detection, PHCs can track conditions continuously and respond immediately to preserve potency. As a result, spoilage rates decrease, ensuring more vaccines reach the intended populations safely and effectively.

AI-Based Vaccine Stability Prediction leverages predictive models to forecast vaccine potency degradation, remaining shelf-life, and time-to-failure based on exposure history. This approach enables proactive dispatching and administration of vaccines before their efficacy diminishes. By prioritizing vaccine movement according to stability forecasts, stability prediction supports higher levels of distribution efficiency and minimizes emergency resupply needs (Okoro et al., 2022). Distribution efficiency, a dimension of the dependent variable, refers to streamlined logistics in vaccine delivery. Improved efficiency is reflected in reduced lead times, higher on-time delivery rates, and fewer urgent resupply requests. When AI stability prediction is applied to vaccine scheduling and inventory management, PHCs can achieve smoother supply chains and better service continuity for immunization campaigns.

AI-Driven Distribution Optimization involves leveraging AI for demand forecasting, inventory rebalancing, and routing optimization. By analyzing historical and real-time data, AI can ensure equitable allocation of vaccines and reduce inefficiencies in transport logistics. This is especially critical for reaching underserved rural and peri-urban populations where vaccine access is traditionally limited (Nwankwo & Eze, 2021). Vaccine Availability and Accessibility is measured through stock-out reduction, uninterrupted service provision, and the ability to deliver vaccines to hard-to-reach communities. AI-driven distribution optimization ensures that resources are positioned where they are most needed, thereby enhancing last-mile reach and equity in vaccine distribution. Ultimately, the use of AI strengthens the resilience of PHCs and supports Nigeria's national immunization objectives (Oladipo & Bello, 2024).

Theoretical Framework

This study is anchored on the Resource-Based View Theory by Barney (1991), which emphasizes that organizations achieve sustained performance by leveraging valuable, rare, inimitable, and non-substitutable resources. In

the context of PHCs, AI-driven cold chain monitoring can be regarded as a strategic resource that strengthens immunization programs by reducing spoilage, improving efficiency, and increasing community trust in healthcare delivery.

However, critics argue that RBV downplays external constraints such as poor infrastructure and regulatory bottlenecks (Priem & Butler, 2001). In Nigeria, factors like weak electricity supply, internet connectivity challenges, and limited government funding for PHCs significantly influence outcomes (Okonkwo & Musa, 2022). Nonetheless, RBV remains relevant as it frames AI adoption in PHCs as a competitive advantage that enhances the efficiency of Nigeria's national immunization programs, particularly in underserved regions

Empirical Review

PubMed Central, (2025) investigated how routine immunization services could be integrated with COVID-19 vaccination, drawing on both program records and stakeholder inputs. A mixed-methods approach was adopted, combining service statistics with qualitative analysis of integration processes. The study concluded that integration improved coverage and session delivery but also identified persistent cold chain and logistics bottlenecks, especially during vaccination surges. However, the study focused mainly on integration and coverage outcomes, without exploring AI analytics, sensor-based monitoring, or time-to-respond to cold chain excursions. Our research fills this gap by isolating AI-specific effects on distribution efficiency and stock-outs in PHCs, while complementing integration lessons with digital performance metrics.

BioMed Central (2024) explored Provider and community perceptions of integrated COVID-19 and routine immunization in Nigeria using perceptions of healthcare workers and community stakeholders through a qualitative design using purposive sampling. In-depth interviews and focus group discussions were analyzed thematically. The findings showed that

while integration was perceived to streamline services, it also strained cold chain logistics, data systems, and the health workforce. Despite its rich qualitative insight, the study did not provide quantitative cold chain performance indicators or AI-based monitoring, limiting its generalizability. Our study builds on these insights by offering quantitative evidence on how AI monitoring mitigates the logistical strains highlighted by providers, linking these to measurable PHC outcomes.

BMJ Global Health (2025) examined the influence of climate-related stressors on cold chain efficiency in Ogun State, Nigeria. The observational study collected data from PHC facilities and storage points using environmental and logistics records to evaluate temperature excursions and system performance. Findings revealed that elevated ambient temperatures and extreme weather increased storage risks and undermined logistics performance. While the study highlighted vulnerabilities, it relied largely on manual data collection and did not test AI-based mitigation strategies. Our research directly addresses this limitation by evaluating AI driven anomaly detection and predictive modeling as adaptive responses to climate-exacerbated risks in PHC cold chains.

SpringerLink (2024) evaluated NAFDAC's quality control of COVID-19 vaccines imported into Nigeria, the study presented regulatory evaluations and lot release summaries covering 2021–2022. The national-level study focused on laboratory quality control protocols applied to imported vaccine lots, ensuring product integrity prior to distribution. Although the findings underscored the importance of maintaining stringent standards at the import stage, the study did not extend to downstream PHC cold chain performance or AI-enabled monitoring during last-mile delivery. Our research bridges this gap by examining last-mile PHC performance through AI telemetry and analytics, thereby connecting import-stage quality control to delivery outcomes at the point of use.

Study Gaps

Most existing studies have focused on integration, coverage, or regulatory oversight without isolating the direct effects of AI-driven anomaly detection, stability prediction, or distribution optimization on PHC outcomes. For example, *PMC (2025)* investigated the integration of routine immunization and COVID-19 vaccination, identifying cold chain and logistics bottlenecks but did not examine AI monitoring or response times to excursions. Similarly, *SpringerLink (2024)* evaluated NAFDAC's quality control of vaccine imports, emphasizing upstream laboratory checks but leaving downstream PHC-level AI-enabled monitoring unexplored. Our research addresses this gap by isolating AI-specific effects on cold chain performance in Abuja PHCs. Few studies provide quantitative linkages between digital tools and outcomes such as spoilage reduction, on-time delivery, or stock-out rates. *BioMed Central (2024)* explored provider and community perceptions of integrated vaccination and reported strains on cold chain logistics, but its qualitative design offered no measurable indicators of spoilage or availability. Likewise, *PMC (2025)* focused on coverage improvements without reporting quantitative cold chain performance outcomes. This creates an outcome gap, which our study fills by offering empirical statistical evidence on how AI analytics improve spoilage reduction, delivery efficiency, and vaccine availability at PHCs.

This study addressed these gaps by operationalizing three AI proxies; machine learning, real time data analysis, and IOT sensor, measuring three dependent variable proxies; spoilage, efficiency, and availability at the PHC level, and estimating effects using inferential statistics within the Nigeria/FCT-Abuja context.

METHODOLOGY

This study adopted a case study research design focusing on Primary Health Care (PHC) centers in Nigeria, with particular emphasis on facilities in the Federal Capital Territory (FCT), Abuja. The design was suitable as it enables in-depth

exploration of how AI-driven cold chain monitoring systems can improve vaccine preservation, distribution, and availability in resource-constrained contexts (Creswell & Creswell, 2023). The study population comprised staff directly involved in immunization programs, including cold chain officers, nurses, PHC coordinators, community health extension workers (CHEWs), and local government health authority staff. While there are over 34,000 PHCs and approximately 250,000 health workers nationwide (NPHCDA, 2023), the study focused on Abuja due to recurring cold chain challenges such as irregular power supply and logistical bottlenecks (Adebisi et al., 2022). The target population of the study is an estimated 1,200 immunization staff (NPHCDA, 2023), Using Yamane’s (1967) formula with an estimated 1,200 immunization staff and a 0.05 margin of error,

A sample size of 300 respondents was determined. Stratified random sampling was applied to ensure fair representation across professional roles.

Data was collected from both primary and secondary sources. Primary data involved structured questionnaires on a 5-point Likert scale, semi-structured interviews with PHC coordinators and cold chain officers, and observation checklists of cold chain facilities. The questionnaire covered demographic data, AI use in anomaly detection and predictive monitoring, impacts on spoilage reduction and distribution efficiency, and challenges in AI adoption. Validity was ensured through expert reviews, while reliability was tested with a pilot study of 30 PHC staff in Gwagwalada area council, Abuja using Cronbach’s Alpha, with 0.70 as the benchmark for internal consistency

(Adebayo & Oladipo, 2024). Secondary data was sourced from official documents such as NPHCDA reports, WHO and UNICEF publications, and scholarly articles on AI and healthcare logistics (WHO, 2022; UNICEF, 2023).

Data collection was conducted physically at PHCs and digitally via WhatsApp and Google Forms, with follow-up reminders to improve response rates. Interviews was recorded and transcribed, while observation checklists was assess infrastructure readiness. Data analysis employed descriptive statistics (frequencies, percentages, means, and standard deviations) and inferential statistics through multiple regression to test relationships between AI-driven monitoring systems (independent variables: machine learning, real time data analysis, and IOT sensor) and cold chain performance (dependent variables: spoilage reduction, efficiency, availability), using SPSS version 27 with significance at $p < 0.05$. Ethical standards was upheld through informed consent, confidentiality, voluntary participation, and approvals from the Federal Ministry of Health Ethics Committee and relevant State Primary Health Care Development Agencies, ensuring compliance with both Nigerian and international research guidelines (WHO, 2022; NAFDAC, 2023).

ANALYSIS

Table 4.1: Vaccine Spoilage Before and After AI Adoption

Operational records from PHCs in Abuja indicated that before AI adoption, average vaccine spoilage due to temperature excursions and delayed detection stood at 8.4%. Following the introduction of AI-driven monitoring, spoilage declined significantly to 2.6%,

representing a 69% reduction in wastage. This decline was attributed to real-time alerts and anomaly detection, which enabled staff to respond quickly to power outages and refrigeration failures.

AI-enabled predictive analytics and GPS monitoring optimized routing and reduced delivery delays from the FCT cold store to PHCs. Average delivery lead time reduced from 3.9 days to 2.5 days, while on-time delivery

performance improved from 68% to 89%. This improvement was particularly noted in rural PHCs in Kwali and Abaji, where delays were previously frequent.

AI-driven anomaly detection significantly improved system responsiveness. Average response time to temperature excursions dropped from 3.8 hours to 40 minutes, reducing the

likelihood of vaccine potency loss. This demonstrates the capacity of AI monitoring to prevent wastage through early intervention.

Stock-out records showed that vaccine unavailability at PHCs dropped from 14% to 5% after AI system adoption. Predictive analytics

improved inventory visibility and enabled proactive reallocation of vaccines between urban and rural PHCs in Abuja.

The R-square value of 0.682 indicates that approximately 68% of the variation in cold chain performance (spoilage reduction, efficiency,

availability) in Abuja PHCs is explained by AI proxies (anomaly detection, predictive analytics, and distribution optimization).

The p-value ($0.000 < 0.05$) confirms that the regression model is statistically significant,

indicating that AI-driven monitoring has a strong and positive effect on vaccine preservation and distribution performance in Abuja PHCs.

All three AI proxies significantly contribute to cold chain performance ($p < 0.05$). Among

them, real time data analysis had the strongest impact ($\beta = 0.452$), followed by machine learning ($\beta = 0.413$) and IOT sensor ($\beta = 0.362$).

Test of Hypotheses

Hypothesis One:

The study formulated and tested the following hypotheses at a 5% level of significance ($0.05\alpha=0.05$):

H₀₁: Machine learning does not significantly affect cold chain performance in PHCs.

From Table 4.7, the coefficient of machine learning is $B = 0.462$, with $t = 2.91$ and $p = 0.008 < 0.05$. Since the p-value is less than 0.05, we reject H_0 and accept H_1 . This implies that machine learning has a positive and significant effect on cold chain performance. Timely detection of temperature anomalies reduces spoilage and improves vaccine preservation.

Hypothesis Two:

H_{02} : Real time data analysis does not significantly affect cold chain performance in PHCs.

From Table 4.7, real time data analysis has a coefficient of $B = 0.531$, with $t = 3.61$ and $p = 0.002 < 0.05$. Since the p-value is below 0.05, we reject H_0 and accept H_1 . This shows that real time data analysis has the strongest positive effect on cold chain performance, enhancing accurate forecasting, reducing delivery lead times, and improving stock availability.

Hypothesis Three:

H_{03} : IOT sensor does not significantly affect cold chain performance in PHCs. From Table 4.7, the coefficient of IOT sensor is $B = 0.377$, with $t = 2.73$ and $p = 0.012 < 0.05$. Since the p-value is less than 0.05, we reject H_0 and accept H_1 . This indicates that IOT sensor significantly improves cold chain performance by reducing delivery delays and increasing on-time delivery rates, particularly in rural PHCs.

Discussion of Findings

The findings align with the research objectives and confirm the hypotheses: machine learning significantly reduced vaccine spoilage by ensuring timely identification of temperature excursions. This supports WHO (2021), which emphasized that machine learning are essential for minimizing vaccine losses in LMICs (low- and middle-income countries). Real time data analysis enabled accurate demand forecasting and routing optimization, reducing delivery lead times. This finding aligns with NPHCDA's (2023) strategy of digitalizing vaccine logistics in Nigeria.

Real time data analysis improved last-mile delivery, reducing stockouts and ensuring higher

vaccine availability in both urban and rural PHCs within Abuja. This is consistent with Patel et al. (2023), who highlighted AI's role in strengthening pharmaceutical access in underserved areas. The study confirms that AI-driven cold chain monitoring significantly improves vaccine preservation, reduces wastage, and enhances availability in PHCs within FCT, Abuja. However, the findings also highlight contextual challenges such as unreliable electricity supply, insufficient ICT capacity among PHC workers, and limited funding for sustained system deployment.

Conclusion

Based on the findings, the study concludes that AI-driven cold chain monitoring systems play a critical role in ensuring vaccine potency, safety, and accessibility within Nigeria's PHCs. By enabling machine learning, real time data analysis, and IOT sensor, AI significantly reduces vaccine wastage and strengthens the reliability of immunization programs.

The research further concludes that while AI technologies provide promising outcomes, their effectiveness is contingent on supportive infrastructure, adequate funding, and capacity building among healthcare personnel. Without addressing these enabling factors, the benefits of AI may not be fully realized in many underserved areas. Overall, the study highlights that AI is not a replacement for existing cold chain systems but rather an enabler that complements and enhances vaccine distribution in Nigeria's healthcare delivery system.

Recommendations

In light of the findings and conclusions, the following recommendations are proposed:

- i. Federal and State Governments should prioritize the deployment of AI-driven machine learning systems in all PHCs, especially in rural areas.
- ii. Healthcare workers should be trained on how to use AI systems effectively, interpret data, and respond to alerts.

- iii. Encourage collaboration between tech companies, NGOs, and government agencies to expand the deployment of AI driven cold chain monitoring systems
